part and the Parish Council of Sproughton of the other part

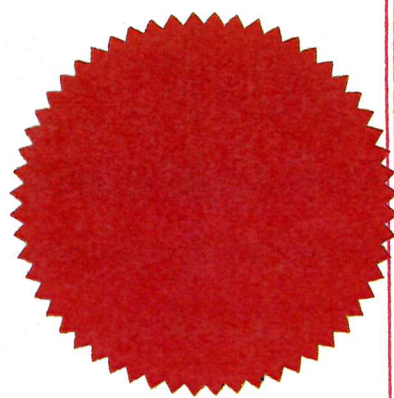
